PURPOSE:

Patient Safety and Clinical Quality Improvement (PS and CQI) are hallmarks of patient care excellence. Accrediting bodies and payors, as well as the public, expect physicians to be proficient in understanding and taking active roles to ensure any care environment has focus on PS and QI.

POLICY:

Each residency program must have a PS/QI project active each academic year. The procedure below will constitute a Patient Safety and Quality Improvement Curriculum that each residency program must utilize.

PROCEDURE:

Didactic Experience:

As of July 1, 2016, MSVMC will utilize a GME Institutional Curriculum. This curriculum contains modules containing education on Patient Safety and Quality Improvement principles and how they intersect with the care we give. (See appendix A and B)

Practical Experience:

- 1. Each residency program must develop a meaningful clinical quality improvement project. Such projects can be clinic/ambulatory based or inpatient, ED or other unit. The project must have:
 - Faculty supervisor/approval of the involved units/clinics
 - Meaningful involvement of each resident (individual participation may vary based on role/time)
 - Each project will be led by residents. Each step of the project should be resident driven under the guidance of the faculty supervisor.
 - Timeframes are flexible. Residents may choose to focus on a discrete item that may lead to a six month long project or one that could involve multiple years. However, at least one project must be active in each program in each academic year.
 - E.g.: Residency A completes a QI project on improving smoking cessation rates in the clinic. The project was started in October 2012 and finished in May of 2012. Another active project must be initiated within the next academic year.
 - Programs will report their current status of the project at assigned times during a scheduled GMEC meeting.
- 2. Due to the lack of a "home site" or focus of specialty, the TY program will not be required to develop program level projects. TY residents must complete the didactic curriculum.
